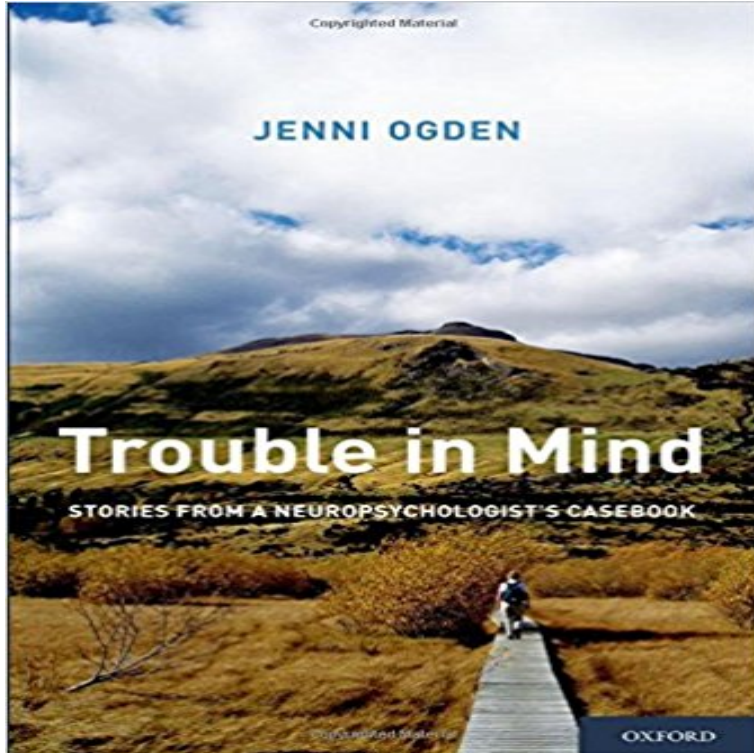


# Trouble in Mind: Stories from a Neuropsychologists Casebook

For health professionals and researchers working with these patients, the ethical and emotional challenges can be as demanding as the intellectual and treatment decisions they make daily. *Trouble In Mind* is written in an accessible narrative style that is both accurate and intimate.
