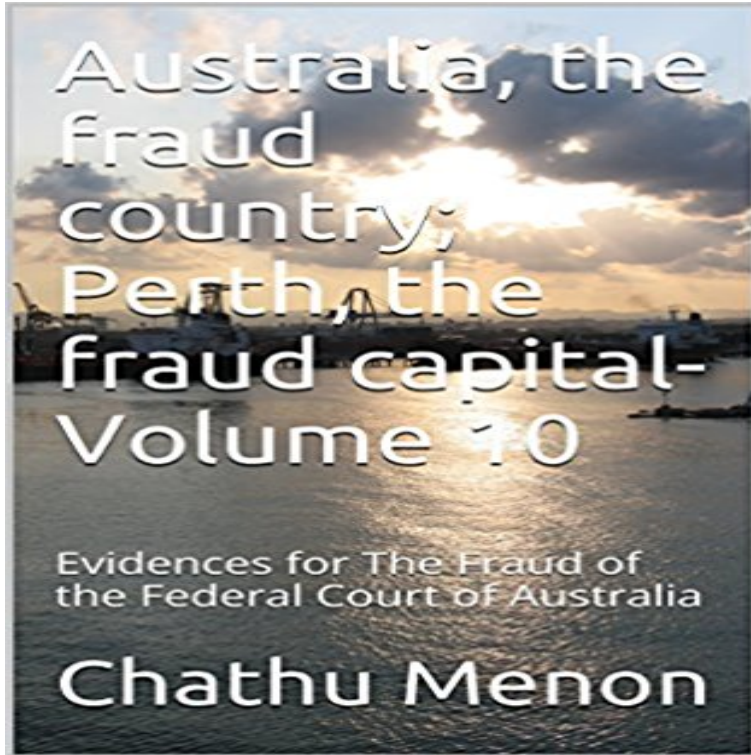


Australia, the fraud country; Perth, the fraud capital-Volume 10: Evidences for The Fraud of the Federal Court of Australia
