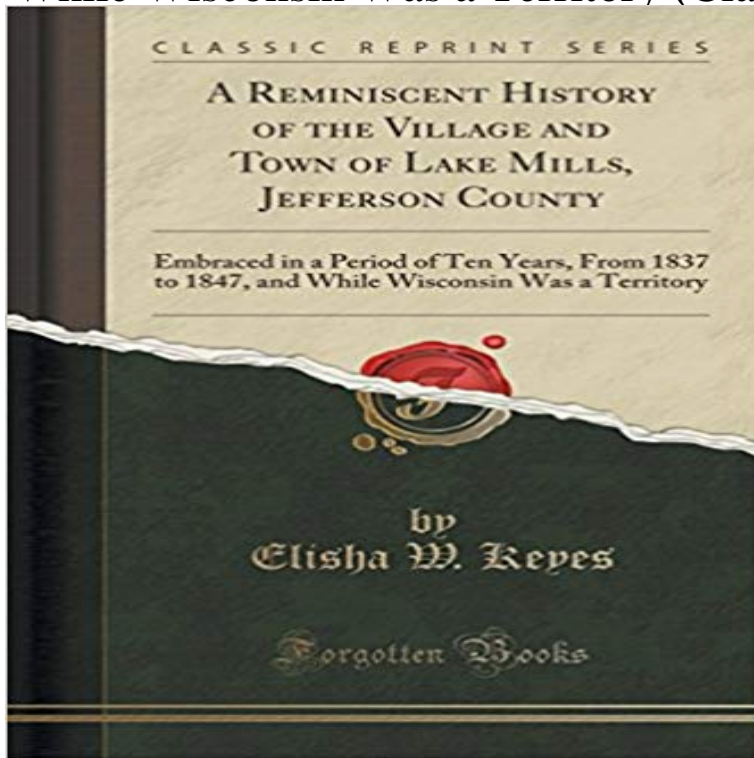

From the storehouse of that memory, I have brought forth the facts and reminiscences embodied in this address. Fiction is given no place and nothing is credited to the imagination. I only fear you may set down as trifling and uninteresting, so much that is necessarily personal to myself in many of the incidents herein related. But, being dear to me, I submit them to your kindly interest. I remember when a boy in Vermont my father procured an old-fashioned atlas, with the apparently unsettled northwest territory traced upon it, and calling my older brothers to him, pointed with his forefinger on the map to that portion of the territory which began along the southern point of Lake Michigan, and extending therefrom in a northwesterly direction. He pointed to the mouth of the Milwaukee river, and, said he, Boys, theres where we want to go; that country offers splendid inducements for settlers.
