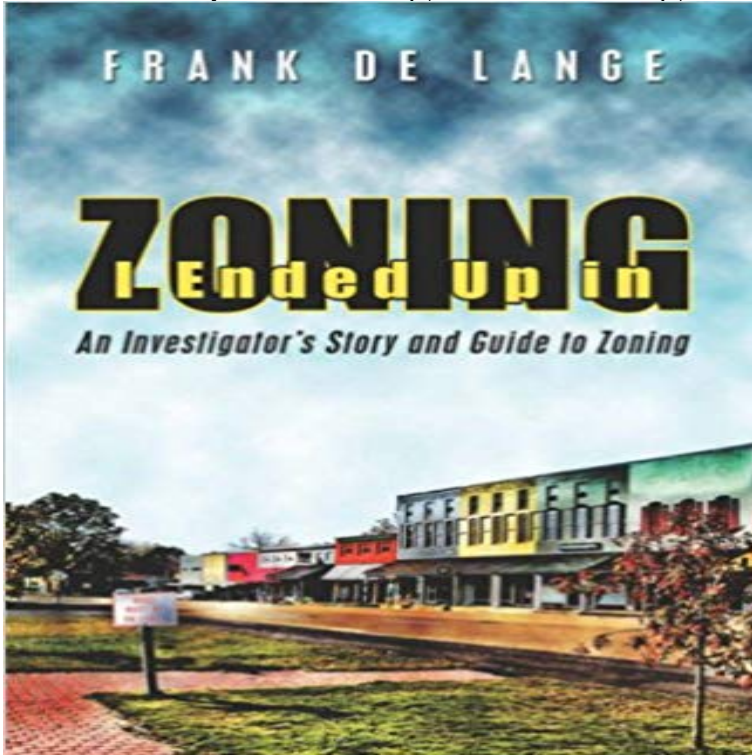


I Ended Up in Zoning: An Investigators Story and Guide to Zoning
