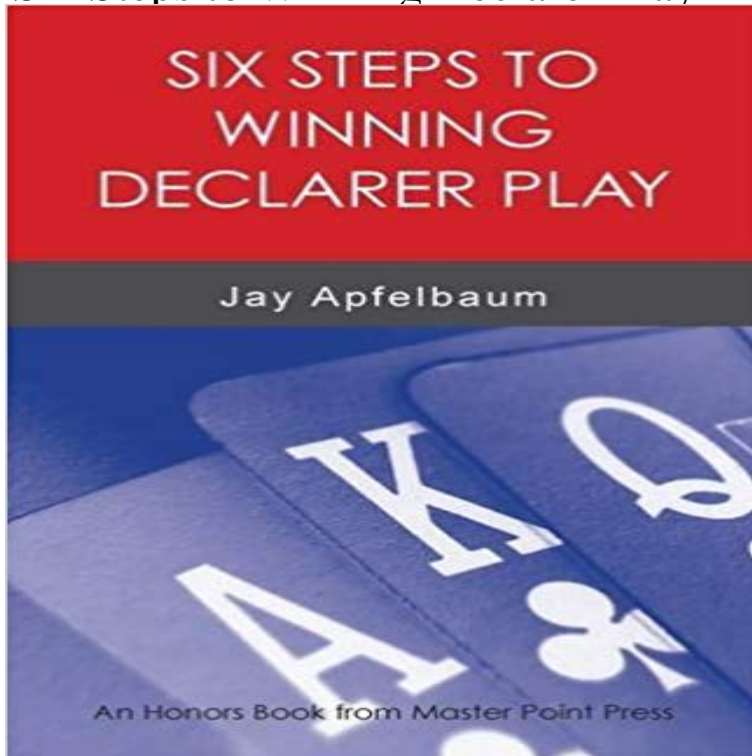


Six Steps to Winning Declarer Play
