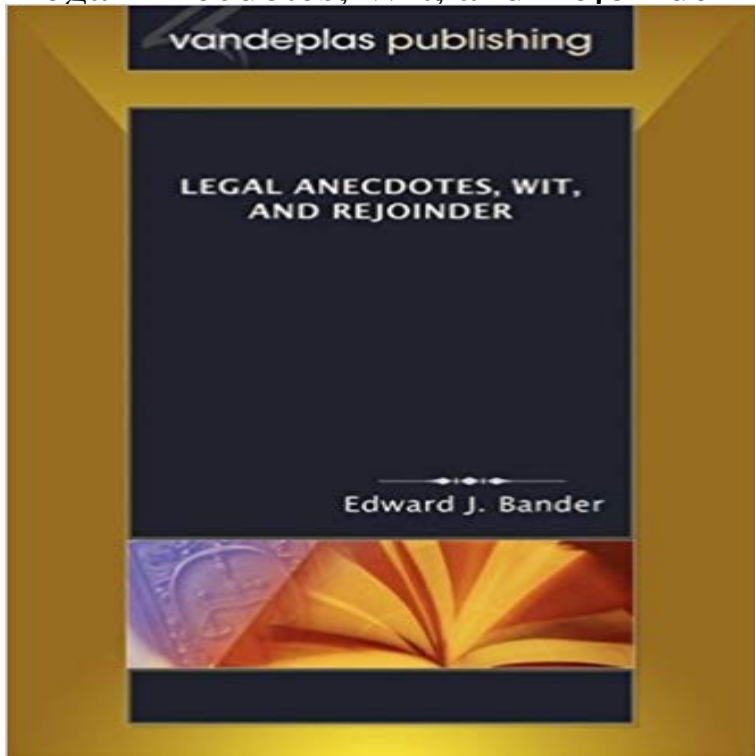


Legal Anecdotes, Wit, and Rejoinder
