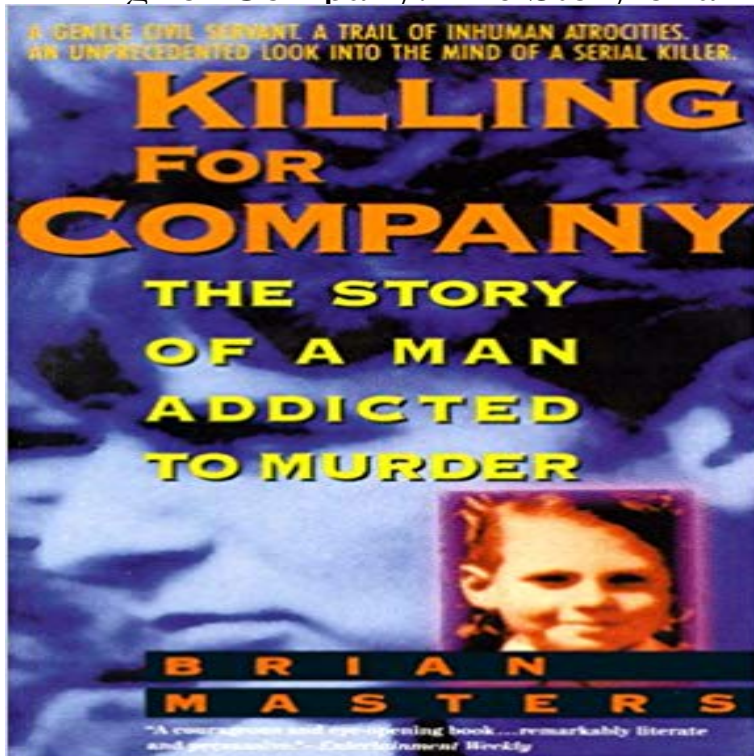


Killing for Company: The Story of a Man Addicted to Murder
