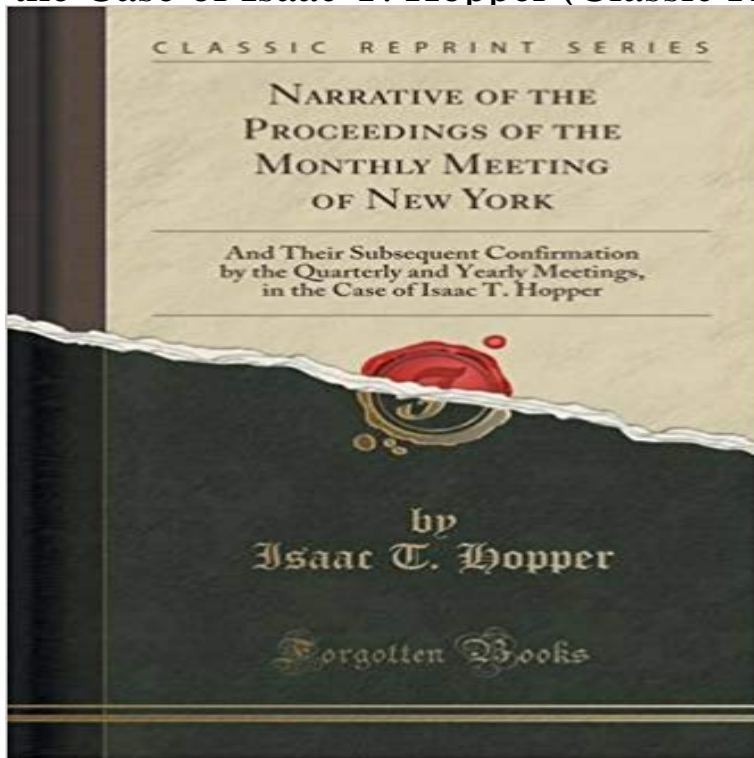

The arraignment and subsequent disownment of Charles Marriott, James S. Gibbons, and myself, by the Monthly Meeting of New-York, having given rise to much misrepresentation, and having also created considerable speculation and excitement in different parts of the country, I have thought it right to give a brief history of my case, and some facts connected with it. Upon much reflection, I have believed such a course is due to myself, and to the Society of Friends, with which I have been connected, and which I have sincerely loved from an early period of my life. On the morning of the 29th of third month, 1841, I was called upon by Amos Willets, who requested me to meet the overseers of the Monthly Meeting of New-York on the evening of the same day, at Hester-street Meeting-house. My son-in-law James S. Gibbons, had received a similar request from another overseer. Charles Marriott was absent from the city. We met accordingly, and instead of finding the overseers of Hester-street Preparative Meeting merely, we were surprised to find assembled those of the other two Preparative Meetings, viz.
