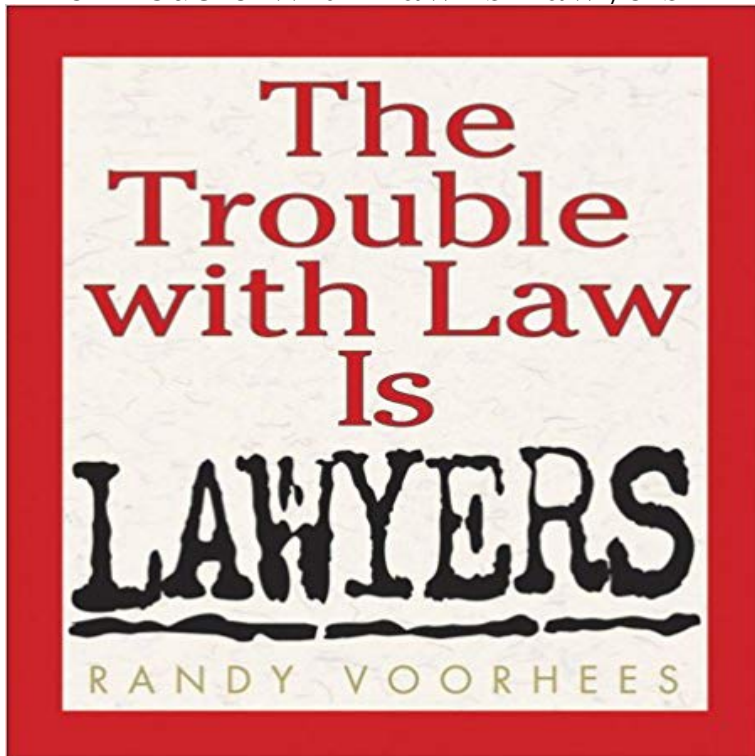


The Trouble With Law Is Lawyers
