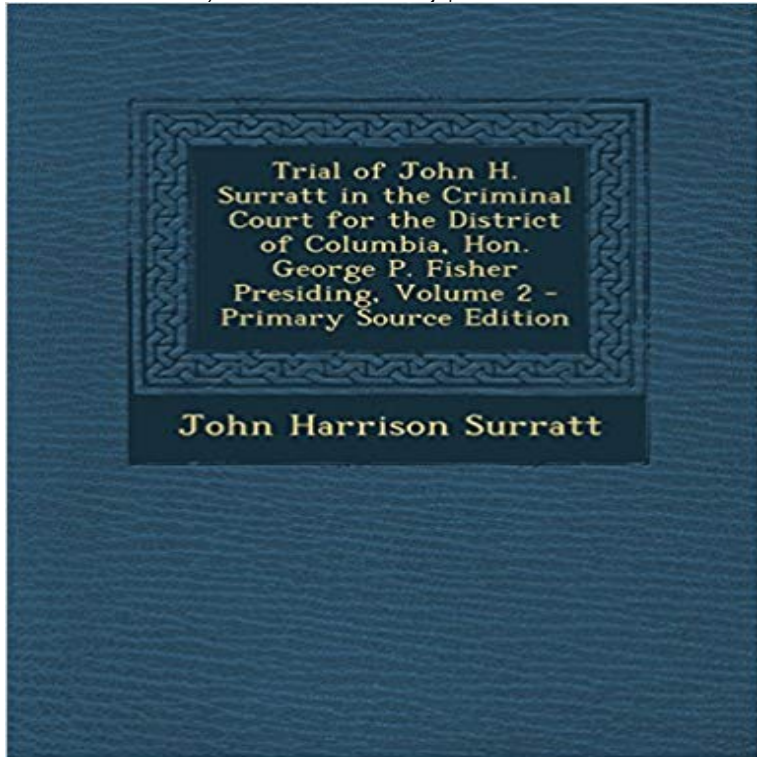


Trial of John H. Surratt in the Criminal Court for the District of Columbia, Hon. George P. Fisher Presiding, Volume 1
