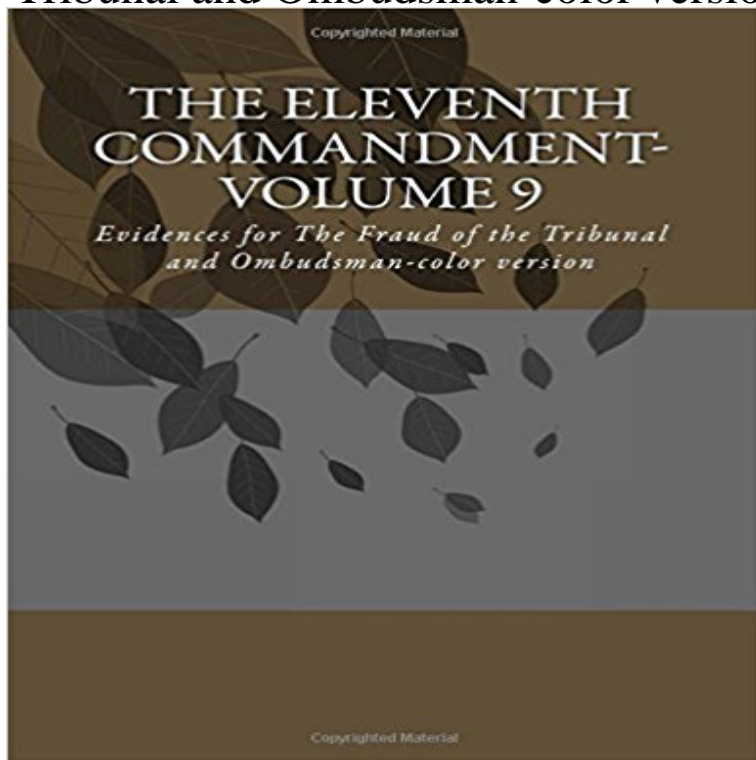


The Eleventh Commandment-Volume 9: Evidences for The Fraud of the Tribunal and Ombudsman-color version
