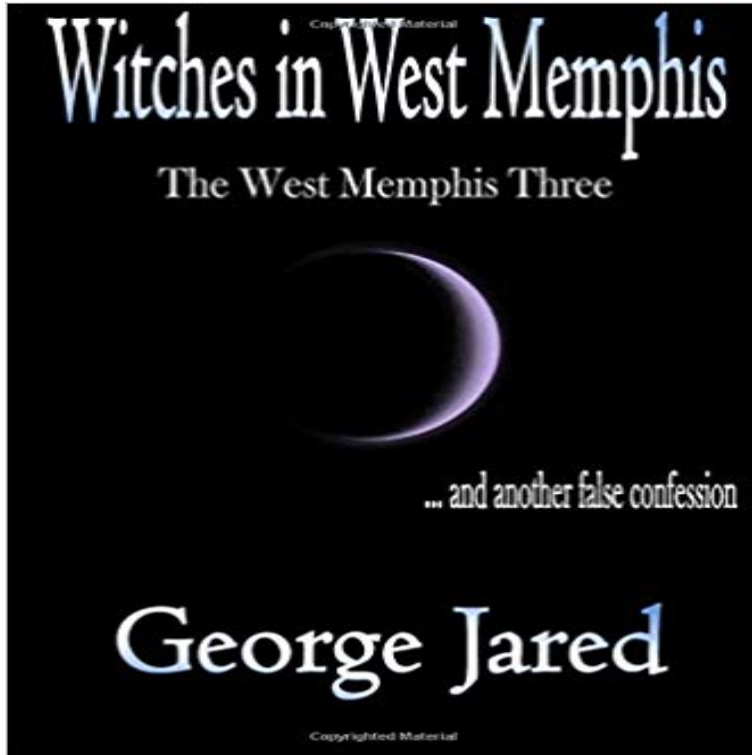


## Witches in West Memphis: The West Memphis Three and another story of false confession



This might be the most unjust prosecution in U.S. legal history. If you think what happened to Steven Avery in the true crime film, *Making a Murderer*, was shocking you will be completely appalled by what happened to three little boys and three teens in Arkansas in 1993. Three 8-year-old boys vanished from their West Memphis neighborhood one sunny afternoon. A day later their mangled, nude bodies are found in a drainage ditch. His best-friend, Jason Baldwin, and another teen known to them, Jessie Misskelley Jr., are arrested June 3, 1993, and charged with murder. No real evidence tied the teens to the crime, but an error-riddled confession by Misskelley was the proof used to seal the verdicts in the case. Witnesses changed their statements. New suspects rose to the surface.
