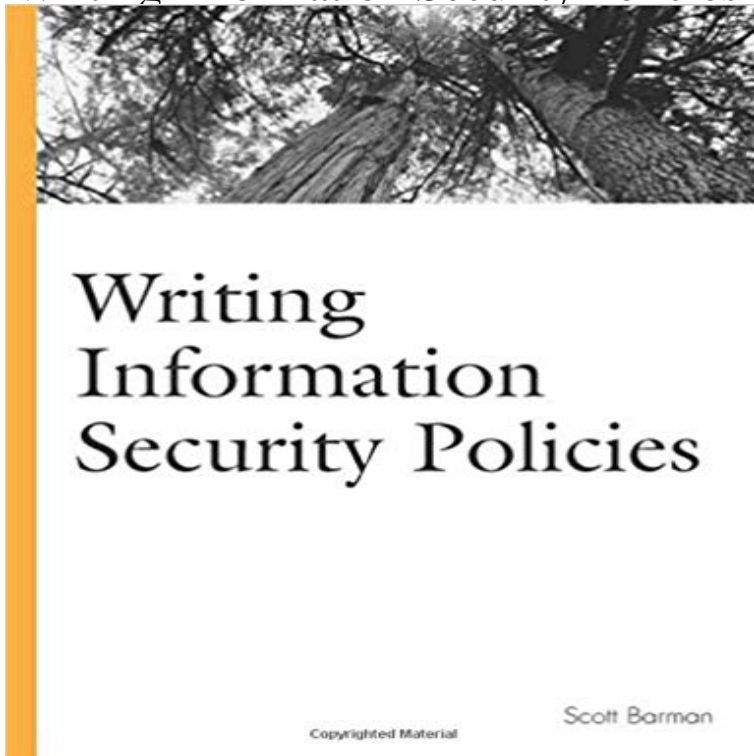


Writing Information Security Policies

As technology and business requirements change, the policy must be updated to reflect the new environment--at least one review per year.
